### DS-260 and DS-261 - About These Online Forms - Immigration ...

Civil documents must bear an original signature, stamp, and seal of the issuing office or registrar. Copies certified by attorneys, Justice of the Peace, Notary Public, etc., are not acceptable. For any document not in English or in the official language of the country from which you are applying, a notarized translation is required in addition to the original.
